Dear Friends and Neighbors,

I would like to wish everyone a Happy and Healthy New Year. We hope everyone enjoyed the holidays and are glad so many of you were able to join us for our annual Christmas Tree Lighting Ceremony. We want to thank the WARM Association of Girl Scouts, our neighbor and ASCA sponsor Zdenko Beg, PT and the Albertson Fire Company for helping to make the event a success. We are looking for a volunteer to have the Menorah moved, stored and displayed including lighting seasonally. If anyone is interested, please contact the ASCA.

Our next member meeting will be Tuesday, Feb. 25th 7:30 PM at the Albertson Fire House. This will be a special meeting honoring one of our local Police Officers. We want to recognize Officer Lamonta for going above and beyond her duties when she came to the aid of one of our residents. We have also invited members of the Nassau County 3rd Precinct POP Unit to discuss the NYS Bail Reform Law changes and how it will affect our community.

Already this year, the ASCA has been active in representing Albertson's interests before the Town of North Hempstead. We are continuing to monitor activity on Branton Place. Neighbors from that block along with one of our Board members recently met with Town Supervisor Judi Bosworth and District Councilman Peter Zuckerman to discuss enforcement of Town ordinances on rental properties and occupancy. The ASCA has also gone before the Town Board of Zoning Appeals on matters of interest to our community. We joined to advocate for a successful outcome on a Zoning Board appeal for a neighbor on Oak Ridge Lane. Unfortunately we were not as successful with a proposed variance requested by a developer to build 2 houses on 1 oversized lot on Netz Place that was brought to our attention by several of our neighbors. Although we had the support of the community and the Town Board, the BZA granted the appeal. Please let us know of matters before the Town Zoning Board that you feel may not be in the best interest of the Albertson Community. We may be able to join in advocating for or against undesirable outcomes.

The ASCA also attends and participates in meetings with Planesense4LI, the organization that is trying to address the excessive airplane noise. We encourage all of you to visit the airnoise.io website for more information about this issue and an easy way to file complaints against specific low flying jets.

Finally, it's time to renew your ASCA membership. Please mail in your membership dues today or renew at the February 25th meeting. Please speak with your neighbors, advise them of the good work we are doing and encourage them to join. We'd especially like to hear more from our new neighbors in our community.
